Gramlich, nationally renowned as a leading expert in GI and liver pathology, joined AmeriPath in January 2003 as director of hepatopathology at the AmeriPath Institute of Gastrointestinal Pathology and Digestive Disease. Dr. Gramlich is a graduate of the West Virginia University School of Medicine, Morgantown, and completed his pathology residency at the Medical University of South Carolina, Charleston. Dr. Gramlich completed a subspecialty fellowship in cytopathology at the Medical University of South Carolina, where he was also appointed as an American Cancer Society® clinical oncology fellow. He received additional subspecialty training in GI pathology at the Case Western Reserve University School of Medicine/University Hospitals of Cleveland. Prior to joining AmeriPath, Dr. Gramlich served as an assistant professor of pathology at Emory University, Atlanta, Georgia, and was a principal GI and liver pathologist at the Cleveland (Ohio) Clinic Foundation. Dr. Gramlich has coauthored over 150 published articles on a variety of GI disease-related subjects, including chronic hepatitis C, nonalcoholic steatohepatitis, and the diagnosis and management of patients with inflammatory bowel disease or Barrett's esophagus.
